Information regarding the 2015-2016 tax levy and the 2015-2016 budget for the Kaukauna Area School District was presented.

Action Items

Tim Reichenberger made a motion to set the 2015-2016 tax levy at \$17,811,016. The tax levy sets the mill rate at \$9.13 per \$1,000 of property value. John Moore seconded the motion. A roll call vote was taken: Reichenberger-yes, Bouressa-yes, Gertz-yes, Kelly-yes, Moore-yes, Miller-yes, Feller-yes. Motion passed 7-0.

Tim Reichenberger made a motion to set the 2015-2016 operating revenue budget at \$46,508,693 and the 2015-2016 operating expenditure budget at \$48,199,826. The overall operating revenue budget for KASD will be \$53,967,360 and expenditures will be \$56,805,888. A roll call vote was taken: Reichenberger-yes, Bouressayes, Gertz-yes, Kelly-yes, Moore-yes, Miller-yes, Feller-yes. Motion passed 7-0.

Sue Gertz made a motion to approve the Youth Options Course Requests. Sam Kelly seconded the motion. The motion passed 7-0.
